EXHIBIT A

PARCEL I:

A parcel of land located in the Southwest One-quarter of Section 22, Township 31 North, Range 13 East, Allen County, Indiana and more particularly described as follows:

Commencing at the southwest corner of Lot #1 in Maplewood Terrace, Scotion I, as recorded in Plat Book 27, pages 103-105 in the Allen County Recorder's Office, said point located 61.2 feet north of the southeast corner of the West One-half of the Southwest One-quarter of said Section 22 according to said recorded plat, this point located on the North 60 foot right-of-way line of Stellhorn Road; thence North 00 degrees 07 minutes East (bearing based on said plat) along the West line of said plat and described as the East line of the West One-half of said Southwest One-quarter and along the East line of a tract of land described DOC. #960056582, a distance of 86.83 feet to the northeast corner of said aforementioned tract, said point being the point of beginning.

BEGINNING at the above described point; thence south 89 degrees 45 minutes 33 seconds West and parallel to the north 60 foot right-of-way line of Stellhorn Road along the North line of the aforementioned tract, a distance of 138.08 feet to the northwest corner of said tract as marked by a P.K. nail found; thence North 00 degrees 07 minutes East and parallel to the West line of said Maplewood Terrace, Section I, a distance of 136.0 feet to a five-eighths inch diameter steel pin set with D&A Firm No. 0026 identification cap; thence North 89 degrees 45 minutes 33 seconds East, a distance of 138.08 feet to a point on the West line of said Maplewood Terrace, Section I as marked by a five-eighths inch diameter steel pin set with D&A Firm No. 0026 identification cap; thence South 00 degrees 07 minutes West along said West line, a distance of 136.0 feet to the point of beginning, containing 0.43 acres of land, more or less.
