Commissioning: In the event that the commissioning is delayed or rescheduled by the Buyer beyond the commissioning date agreed with Nothum, the retention amounts will be paid by the Buyer as though commissioning were carried out on the agreed date. Payment shall be paid to Nothum within 10 days of the invoice date (unless stated otherwise) and in the default of due payment, the amount outstanding shall bear interest at the rate of 1½% per month. In the event of such a delay or rescheduling of the delivery date, the Buyer agrees to pay Nothum's invoices for the Goods (or, if not completed, that portion of the Goods which is ready for delivery) as though delivery were made on the estimated date of delivery. The Goods shall remain the sole and absolute property of Nothum as legal and equitable owner until such time as the Buyer has paid to Nothum the price due. Funds to be sent by wire transfer in US funds.

In the event commissioning cannot occur on the agreed upon date due to a state of national health emergency or pandemic, each party will use all reasonable efforts to complete the engagements as specified herein, so long as each can reasonably do so while also protecting the health, welfare and safety of its professionals and the public, and abiding by emergency or regular executive orders, or changes in law mandated to address the pandemic. Neither party shall be liable for any delay or failure in performance (excluding payment for fees and expenses incurred) due to circumstances resulting from the national health emergency or pandemic which are beyond its reasonable control.

Payment Terms: Equipment terms are 60% due upon purchase, 30% due prior to shipment, 10% Net 30 days. International (Outside the United States and Canada) Service and Technical Sales terms are Net 30 days unless otherwise noted. Spare Parts Sales terms are Net 30 days unless otherwise noted. Equipment Sales terms are listed above, and all deposits are non-refundable, unless otherwise noted.

Shipping: Shipping arrangements are not made until payment is received. All costs attending collection, credits, payment guarantees, etc. are for your account.

All prices quoted are at net cost, Ex Works, Nothum Mfg. Co., Inc. Springfield, Missouri, USA. Prices are quoted firm for a period of 30 days, after which time they are subject to revision. Prices are quoted in US dollars unless otherwise noted. Export crating, inland freight, heavy lifts, handling, ocean freight, insurance, permits, duties, taxes, customs clearance or any other additional expenses incurred during shipment will be invoiced at cost.

Delivery: Delivery dates to be determined. Actual delivery dates will depend on shipping type and conditions. Equipment is not started until 60% deposit, project and product sheets, and approval drawings are received back from the customer. Delivery dates will be adjusted accordingly. Dates may also be altered for late payments. Delivery dates will be determined at receipt of 60% deposit according to the current work load.

Warranty: 1 year on all Nothum manufactured equipment and parts, excluding normal wear and tear to be determined by Nothum. All other parts not manufactured by Nothum carry only the limits of their own manufacturer's warranty. Except as set forth herein, Nothum makes no express warranties as to any matter whatsoever, including, without limitation, the condition of the Goods, its merchantability, or its fitness for any particular purpose. Nothum expressly disclaims any implied warranties, including implied warranties of merchantability or fitness for a particular purpose. The buyer's exclusive remedy for Nothum's breach of this limited warranty to any degree under this contract is to require Nothum to repair or replace, at Nothum's option, any equipment which is non-operational. Nothum shall not be liable for incidental or consequential damages.
